# Celebration Academy School Policies

**Please read and understand each statement below. Your signature at the bottom indicates that you understand and will abide by each policy. Both parents must sign the bottom.**

- We agree to pursue a standard of excellence in education by teaching Biblical principles, life skills, and academics. We also agree to diligently and consistently teach our children a course of study fitting to their physical and mental capabilities, and to provide parental supervision during school hours. At least 50% of all academic, core subjects will be taught at home by us, the parents, for at least 50% of the instruction/learning time. We understand this applies to ALL members, including Partnered Members.
- In our home both parents are in agreement concerning home education.
- We agree to read Celebration Academy's Statement of Faith and agree to respect and support the Biblical principles upon which the Academy is founded.
- We understand that we are responsible for purchasing or acquiring our curriculum and teaching supplies.
- We understand that we must join Home School Legal Defense Association and maintain enrollment throughout the school year.
- We understand as Full or Full Paper Work Only Members, that it is our responsibility to obtain or access the record keeping forms provided by Celebration Academy, before the deadline date when they are due. We will keep records and provide reports to Celebration Academy by the scheduled dates as required. If reports are delinquent, we, as parents, agree to pay the late fees as specified in the handbook. We understand that repeated delinquency results in automatic dismissal from Celebration Academy. We will make copies of everything we turn in to the Academy.
- We agree to insure that our children are in attendance a minimum of 180 days between August 1st of 2018 and July 31st of 2019.
- We understand that Celebration Academy is not Western Association of Schools and Colleges (WASC) accredited, as is the case with many private schools. Although private independent study is a legal option for education in California, it is within the jurisdiction of individual colleges and schools to either accept or deny previous credit earned through Private School Satellite programs such as Celebration Academy. Celebration Academy will provide as much support and assistance as possible should a need arise, but does not accept responsibility for the final decision which rests in the authority of the accepting institution.
- We understand that all fees are not refundable after our completed registration packet is processed and accepted.
- We understand that when our children attend school-sponsored activities, we are required to attend with them and are responsible for their behavior, safety, and supervision or we agree to assign a specific adult to supervise and responsibly fill our position.
- We understand that Celebration Academy is run by a parent volunteer team and is supported by the staff of Celebration Christian Center and each family (PWO exempted) is expected to volunteer. Celebration Academy strives to provide quality educational opportunities and support to its members and is dependent upon the volunteer efforts of its members to achieve this goal. We agree to work with the Celebration Team to fulfill this requirement. If we cannot fulfill this requirement due to family emergencies or health issues, we agree to contact the Celebration Team leader as soon as possible. We understand that failures to commit to or keep the minimum volunteer requirements without approval from the Celebration Academy Team Leader could result in our membership being suspended or (for Full Members) switched to Paper Work Only Membership until reinstated by the Celebration Academy Team Leader.
- We understand that we likely will be contacted throughout the school year by a Celebration Team Member or Celebration Staff Member concerning paperwork, volunteer commitments, or Academy business. Failure to return phone calls, e-mails, or written correspondence or any contact made by a Celebration Team Member or Celebration Staff Member without cause or in a timely manner could result in the termination of the relationship that we have with Celebration Academy or a suspension in our membership.
- We as a Full or Paper Work Only Members, understand that while Celebration Academy is maintaining student cumulative records for our students, Celebration Academy is not responsible for any student's actual education.
- We, as parents of Junior and Senior High Students, understand that while we may design another individual course of study, our students must meet Celebration Academy's graduation requirements in order to receive a diploma from the Academy. Celebration Academy will only issue diplomas to Full and Paper Work Only Members. Partnered Members eligible for 8<sup>th</sup> or 12 grade graduation may participate in Graduation Ceremonies and will receive a diploma authorized/issued by their private school, but purchased by Celebration Academy, through HSLDA.

We have read the above policies and agree to support them to the best of our abilities. We also agree that our relationship with Celebration Academy is by mutual consent and that either we or Celebration Academy may terminate this relationship by written notification at any time. Additionally, a breach in any part of the policy may result in our not being offered registration options with Celebration Academy in the future.
